Unique character (strand C of ETC)



Eligible area

- All EU regions + Norway, Switzerland and the UK

Rationale

- **Objective:** To improve regional development policies, including Investment for Growth and Jobs programmes
- **Means:** Exchange of experience, identification and transfer of good practices

Consequences

- Primarily dedicated to **policymakers**
- **Capacity-building** programme

Identifying good practices



- A policy related initiative (project, process, technique, etc.) which has **proved to be successful** in a region and which can be a **source of inspiration to other regions**"



Les Petits Riens ([2LIFES](#) project) – this good practice is about the well-established network of collection points (600) and second-hand clothing shops (33) in the Brussels Capital Region collecting over 8,000 tons of textiles on yearly basis and contributing to job creation in the fields of collection, sorting, reuse, repair and second-hand sales (over 300 employees, 300 volunteers, training opportunities).

Improving policy instruments



- “a means for public intervention. It refers to any **policy, strategy, or law** developed by public authorities and applied on the ground in order to improve a specific territorial situation”



The **Better Energy Community** is a policy instrument which supports wide-ranging community initiatives, including SME participation, for low carbon economy. It is the national retrofit initiative with grant support of up to MEUR 28 each year. It supports new approaches to achieving energy efficiency in Irish communities. It aims to deliver energy savings to homeowners, communities, enterprises.




Finland participation

Partner involvement per country


Absolute number





Involvement of Finnish regions





MUUTAMIA NOSTOJA SUOMALAIS-HANKKEISTA KAUDELTA 2014-2020:

Research and development:

- **BRIGDES**: LP Kainuun liitto, partnerina Uudenmaan liitto -> biotalouden kehittäminen, osa älykkään erikoistumisen strategioita
- **MARIE**: partnereina Tampereen korkeakoulusäätiö/Tampereen yliopisto, Pirkanmaan liitto -> vastuullisen tutkimus- ja innovatiotoiminnan hyödyntäminen aluekehittämisessä, innovatiopolitiikan työvälineiden kehittäminen (arvot, tarpeet)
- **S34Growth**: LP Suomen Itämeri-instituutti, partnerina Pirkanmaan liitto -> Euroopan teollisuuden ja kilpailukyvyn uudistaminen ja arvoketujen kytkentä (Vanguard-yhteistyö)

Competitiveness of SMEs:

- **iEER**: LP Uudenmaan liitto, partnerina Laurea AMK -> nuorille yrityjille tarjottujen palvelujen kehittäminen, alueiden yhteistyön kehittäminen nuorten yrityjyyden tukemisessa.
- **SME ORGANICS**: partnerina Seinäjoki AMK -> luomusektorin pk-yritysten kilpailukyvyn ja kestävän kehityksen edistäminen alueellisesti

Low-carbon economy:

- **eBussed**: LP Turun AMK -> parannetaan erilaisten alueiden valmiutta ottaa käyttöön uusia sähköbussijärjestelmiä sekä laajentaa ja kehittää jo olemassa olevia. Keinoja mm. vähähiilisen liikkumisen edistämiseen.
- **SME POWER**: partnerina Heinolan kaupunki -> yritysten energiatehokkuuden edistäminen kehittämällä tuki-instrumentteja ja vaihtamalla parhaita käytäntöjä ja kokemuksia (ei-energiaintensiiviset pk-yritykset).

Environment and resource efficiency:

- **Local Flavours**: partnerina Savonlinnan hankekehitys Oy -> kulttuuriperintö seudun elinvoiman lähteenä.
- **BIOREGIO**: LP LAB amk (Lahti), partnerina Päijät-Hämeen liitto -> biokiertotalouden edistäminen: osaamisen jakaminen alueellisista toteutus- ja yhteistyömallista ja teknologioista.
- **SYMBI**: partnereina Hämeen liitto ja Hämeen AMK -> tavoitteena vahvistaa alueiden kykyä rakentaa kestävää taloutta ja hallita ympäristöön ja ilmastonmuutokseen liittyviä haasteita.



Project features

Definition

- partners from different countries working together on a shared regional policy issue

Objective

-to improve the their **regional development policies**

Project features

Evolution of the main features = more **flexibility**

- ‘Lighter’ focus on **Structural Funds** programmes
(only 1 policy instrument per project must be a SF programmes)
- More flexibility in the **phases**
1 core phase & 1 follow-up phase
- **Action plans** depending on core phase results
- **Pilot actions** possible from the start

Project features

Two phases



- **Exchange of experience**
- **Pilot actions** possible
- **Action plan** only if needed



- **Monitoring** the results of cooperation
- Possible continuation of exchange of experience & pilot actions
- Duration: one year

Partnership requirements

Involvement of policy responsible organisations

Creation of stakeholder groups

- Involvement of all relevant organisations in learning process

Contribution to EU cohesion policy

- Wide geographical coverage
- Mixing less with more advanced regions


Projects: who is eligible?

- Public bodies (main target group)
(e.g. local, regional, national authorities)
- Bodies governed by public law (Directive 2004/18/EC)
- Private non profit bodies

Co-financing rates for partners from EU member states

- *80% for public bodies and bodies governed by public law*
- *70% for private non profit bodies*
