

- raising awareness of environment and social aspects




Project approach

- key elements and cross-cutting issues of the Al governance model: legal issues, ethical issues, Al foundational drivers (data readiness and awareness-raising), human capital, access to finance, networking and collaboration, governance strategy
- challenges of applying AI to government operations
- the new EU AI ACT and its implications for government
- business innovations



Experiences and tips - project preparation

Starting point

- Genuine and topical need for policy improvement, and favorable policy framework
 - right policy instrument and its time span, resources, commitment to long-term learning process and policy change
- European-wide relevance and topicality of the expected policy change
 - connection to topical EU policy or legislation; in PLASTIX, the European Strategy for Plastics in a Circular Economy (2018) and the EU circular economy action plan (2020), in Al4Citizens, the EU Al Act
- LP has the privilege to set the agenda/stage/goals for the policy improvement
 - strong own commitment, example and clarity and relevance of the description of the aimed policy improvement help in making European partners interested and committed

Experiences and tips project preparation

Point two, find the right/best partners

- partners who share your policy improvement goals
- use your existing European networks and cooperation experiences, and even build on them, if possible
- with potential new partners, invest in getting on the same page and knowing them (there isn't a shortage of organisations eagerly looking for IE project partnership opportunities)
- do not content yourself with just fulfilling the minimum IE partnership requirements, "four out of the five IE geographical areas are represented in the partnership with at least one project partner" (try to find a candidate country area partner)
- be careful and pedantic with requirements for policy instruments addressed
 - are they for sure eligible "policy instruments", as defined in IE, and are partners policy responsible authorities
 - "at least one of the policy instruments addressed in a project must be an Investment for jobs and growth goal programme" can sometimes be a tricky requirement

Experiences and tips project preparation

Points on application preparation

- invest in Part D of the application form (descriptions of policy instruments and expected policy improvements)
 - most important (and substantial) part of the application
 - coherence between partners' policy improvement goals
 - LP guidance, support and supervision crucial in the preparation of Part D
- if you have two partners from the same country, explain why and added value of having those two partners from the same country
- in the work plan, all activities must be strictly about policy learning and improvement
 - be careful with learning methods and terms used so that no activity refers to policy implementation
 - semesters 7-8 just about monitoring, no more policy learning and improvement
- balanced budget
 - typical mistake: too big partner budgets proposed
 - no partner with a very limited role/budget
 - be specific with external expertise and service cost descriptions

Experiences and tips project implementation

- prompt start is important, do not linger
- build and strengthen coherence and team spirit within the partnership
- IE project is very much about collegial exchange, cooperation and community
 - meet and be in contact frequently/often, also outside eventual project events
 - long-term collegial networks are one of most important by-results of IE projects
- invest in active engagement of regional stakeholders, also interregionally
 - IE project is also about connecting European regional ecosystems
- react promptly to challenges and changes
 - use budget flexibility
 - make possibly needed bigger budget, even partner changes, early enough
 - be open, ready and prepared for pilot actions
